### **County of San Diego:**

Abdi – update of Board of Supervisors vote from 1/14/2020. Unanimous "Yes" for County to resettle refugees. Arrival report December 2019 – 117 resettled, 105 in CalWorks and 12 in WilsonFish. See FY Q1 Report for fuller numbers and statistics.

State Advisory Committee: Abdi - Next meeting will be March 12, 2020 at County Operations Center on Overland. Meeting will cover 1 or 2 days. On last SAC meeting in Sacramento, the committee members decided to have a great representation from ECBOs on the SAC committee; as a result, there were few workgroup created; one of these workgroup consists of Abdi Abdillahi, Zogg Martin, LA IRC Executive Director, and Mohamed Tuama which will be working on defining ECBOs, and mapping the state's ECBOs. State Refugee numbers: FY 2020 Q1 - 301 Refugee, 1402 SIV

National Refugee numbers: FY 2020 Q1 - 3219 Refugee, 3686 SIV

Low numbers generally, 9% of all US refugees resettled in CA, 38% of US SIVs resettled in CA

WilsonFish transition – ORR is not extending WF, ORR requested state to run WF, WilsonFish will continue to work with Catholic Charities locally. The formal agreement was reached and the state run program will run beginning Feb 1. The state is providing cash aid only, support service funds are separate.

Most CA counties have given consent to resettle refugees (all but 1), last day to give consent was 1/21/2020. There is an injunction over the executive order from a Maryland judge who stopped states/counties from giving consent to support refugee resettlement.
